## 'Youth in the world': Cooperation with countries other than the neighbouring countries of the European Union

## Checklist of documents to be submitted with applications

Proposals – submitted in the form of one original copy (clearly identified as such) and one copy – must contain the following documents:

- 1. An official letter of application, dated and signed by the person authorised to enter into legally binding commitments on behalf of the applicant organisation;
- 2. The **preliminary agreements** (Part VI of the application form) of all the partner organisations duly completed and signed (original signatures required);
- **3.** The **declaration on honour** (Part VII of the application form), completed and signed by the person authorised to enter into legally binding commitments on behalf of the applicant organisation, attesting to his/her status as a legal person, to his/her financial and operational capacity to complete the proposed activities and certifying that he/she is not in any of the situations referred to in Articles 93 and 94 of the Financial Regulation;
- 4. The **financial identification form** duly signed by the person authorised to enter into legally binding commitments on behalf of the applicant organisation and certified by the bank (original signatures required); Please fill in the form relating to the country in which the bank is located, even if the applicant organisation is officially registered in another country. - 5. The legal entity form duly signed by the person authorised to enter into legally binding commitments on behalf of the applicant organisation. - 6. A copy of any official document showing the legal entity's name and address and the registration number given to it by the national authorities (for private companies)/A copy of the resolution, law, decree or decision establishing the entity or any official document attesting to the establishment of the entity (for public entities);
- 7. A copy of the VAT registration document if applicable and if the VAT number does not appear on the official document referred to above (private companies)/an official VAT document if applicable (public entities);
- 8. The profit and loss account of the applicant organisation;
- 9. The **balance sheet** for the last financial year for which the accounts have been closed;
- **10.** A **financial report** for the previous year (in euros), covering only operational expenditure, drawn up in accordance with the form available at the website of the EACEA: <u>http://eacea.ec.europa.eu/youth/calls2008/action32/index\_en.htm</u>

Public-law entities and international organisations do not have to submit documents 8-9-10.

All documents must be submitted in one of the official languages of the European Union.
